President Gallagher opened the hearing at 7:40 p.m.

President Gallagher invited any questions from the public –

- Janet Hanson: Ms. Hanson asked why the need for a liquor license at a waffle place. She also asked about the hours.
 - Mr. Emma responded; this is an added feature to the dynamics of how people dine in an upscale application.
 - Mr. Dutton answered the question about hours of service stating Mr. Emma's application falls within the state guidelines.

President Gallagher asked if there was anyone speaking in favor – No comments.

President Gallagher asked if there was anyone speaking in opposition

- Janet Hanson expressed opposition.

President Gallagher entertained any questions from councilors:

- Councilor Fitzgibbons asked the Town Attorney if there any reason to deny that would hold up in court? After a brief discussion, Councilor Fitzgibbons surmised; if there are any violations, they can be addressed through the proper channels.

President Gallagher closed the hearing at 7:48 p.m.

TOWN MANAGER'S REPORT

Mr. Dutton reported on information about various activities happening around town and highlighted meetings and events. Items of note included:

- Mitchell School Update (Standing Item)



Met with Mitchell design team and went over the site plan. Asked them to look a little more closely at the drainage at Wally Krueger Way and Bedford Street. The Demo RFP has been released and is due back mid-end of May. Overall the objective is to do the demolition work over the summer months. The project continues to be on budget. Mr. Dutton reminded all; the total budget is \$80.6MM, a little under \$47MM to be paid by the taxpayers and a little over \$34MM to be paid by the commonwealth. MSBC meetings are typically 2nd and 4th Monday via Zoom. The next meeting is April 27th, then May 4th will be the next date. www.bridgewaterproject.com is the best way to stay current on the project.

- Councilor Fitzgibbons asked if we are on time for state filing deadlines? Mr. Dutton responded; yes. Mr. Fitzgibbons followed up asking; if COVID-19 is challenging the timelines? Mr. Dutton responded; the MSBA seems to be able to continue their work remotely, however if anything changes, he will let the Council know. Finally, Mr. Fitzgibbons asked; now that schools aren't in session, is there any benefit to moving the demo project forward faster? Mr. Dutton responded; the demo timeline is pretty fixed.
- COVID-19 and Budget Impact
Mr. Dutton began stating we have 41 active cases and 34 released from quarantine. There has been 1 death, an 85-year-old male. The state is now reporting on a Town/City basis. The number you might see on the state report may be slightly skewed. They believe the problem is they include all active as well as some of the cases coming out of the DOC Complex. They continue to hold emergency meetings every morning. So far, there are no reported cases among public safety staff. There is 1 confirmed case among staff. We seem to be at the peak. Relative to reopening; it seems to be up for debate. Schools have been closed for rest of year and daycares are closed until June 29th. Employees continue to work from home. Water & Sewer/Roadways and Police & Fire are not working from home but have gone to a split shift to minimize exposure.
Budget impacts: There is legislation coming up to adopt temporary provisions and explained benefits of the legislation. After speaking with the Finance Director today, we're moving into uncharted territory. We are fairly sure there won't be cash flow issues so we're trying to be as accommodating to residents as we can. We are planning for \$1.4MM lower than current projected revenue. State is not going to impact us with any 9C cuts. Looked at salary and wages and projected a surplus of \$473,000 which comes from positions that have not been filled. We'll see surpluses in Police Department for positions unfilled. We think will end with positive cash flow for current fiscal year. We'll have to transfer from stabilization to Golf Course. We've been looking a multiple plans for reopening the golf course.
 - Councilor Fitzgibbons would like to see an analysis of wins and losses to the budget because of the crisis. Mr. Dutton responded the Finance Director has done that type of analysis regularly.Mr. Dutton continued, stating on the revenue side we're conservatively estimating approximately \$680,000 less in general fund revenue and \$113,000 less in State Aid.
 - President Gallagher reconfirmed how much less in State Aid the Town is anticipating. Mr. Dutton reconfirmed \$113,000. President Gallagher asked about relief funding legislation and the relief funding that will be coming to municipalities for the expense related to COVID-19. Mr. Dutton responded; they are tracking some of that legislation and are tracking and segregating the COVID-19 expenses very carefully.
 - Councilor Fitzgibbons asked if the reductions are real and if we're expecting state aide to be less than what we got last year or less than House-1. Mr. Dutton again stated these are conservative estimates, but we're looking at reductions over FY20 levels. We haven't based anything on House-1. Councilor Fitzgibbons stated he would it would be his hope that everyone who has a job June 30, 2020 has job June 30, 2021, Town and School.

President Gallagher declared the motion to approve is back on the floor

Discussion: Councilor Fitzgibbons expressed his desire for a robust discussion as there have been many opinions expressed. President Gallagher is comfortable with the hours submitted. Councilor Rushton expressed the opinion that there is plenty of time before June. In the interest of safety, he doesn't see the need for a long election in the middle of uncertainty. He also appreciated the Town Clerk's opinion on voter turnout. Mr. Ruston is comfortable adjusting to 5:00 p.m. Councilor Colombotos is in agreement with Councilor Rushton but believes the hours should be 10am – 2pm as suggested by the Town Clerk.

Motion: Councilor Colombotos made a motion to amend by changing the hours to 10:00 a.m. - 2:00 p.m. which was duly seconded.

Discussion: Mr. Linde expressed opposition to the proposed hours, noting the cost is already budgeted. Mr. Chase is in agreement with reducing the hours, for this one election, but feels 10am – 2pm is a little short. Councilor Losche would be more in favor of 10am – 4 or 5pm and does not think there would be a significant cost savings. Mr. Sousa would agree with a 10am – 4pm. Councilor George would support 10am – 5pm.

Motion: Councilor Fitzgibbons made a motion to amend the amendment to 10:00 a.m. - 5:00 p.m. which was duly seconded.

Discussion: Councilor Colombotos would much prefer a 10:00 a.m. – 4:00 p.m.

Motion: Councilor Fitzgibbons made a motion suspend the rules and allow the Town Clerk to speak which was duly seconded.

A roll call vote was taken with results recorded as follows:

Ms. Hunt pointed out this is the first weekend of summer and week before 4th of July. She explained her office would be getting the word out. Ms. Hunt addressed the issue of expense. She further noted she has not heard of any concerns. Ms. Hunt stated the cost savings reducing the hours to 10:00 a.m. – 4:00 p.m. would be approximately \$8,000.00. It is Ms.

Hunt's hope that there will be a larger response by offering the absentee ballot. Councilor George asked if there was any reason Ms. Hunt could not hold off on releasing the results until the Raynham polls close at 8:00 p.m. At Councilor George's request, Ms. Hunt spoke briefly about early voting by mail.

Seeing no further discussion on the amendment to the amendment, President Gallagher called for a vote.
