Approval of Meeting Minutes from 6/2/2021

Darren Boston motioned to approve the meeting minutes from 6/2/21 which was duly seconded. The motion was approved unanimously.

Old Business

Round #2 of voting for Final Recommendations

Thomas Golden motioned to add a table of contents to the charter which was duly seconded. The motion was approved unanimously.

Janet Hanson motioned to approve the updated definition for "city" in the "definitions" section of the charter which was duly seconded. The motion was approved unanimously.

Janet Hanson motioned to approve the addition of a comma under the "committee" definition after "investigate" which was duly seconded. The motion was approved unanimously.

Darren Boston motioned to approve the updated definition of "M.G.L." in the "definitions" section of the charter which was duly seconded. The motion was approved unanimously.

Darren Boston motioned to approve the grammar corrections (addition of two commas) in section 2-1b which was duly seconded. The motion was approved unanimously.

Janet Hanson motioned to approve the grammar corrections in section 2-1d3 which was duly seconded. The motion was approved unanimously.

Cleonie Mainvielle motioned to change the language of the "Chief Administrative Officer" definition in the "definitions" section of the charter which was duly seconded. The motion was approved unanimously.

Cleonie Mainvielle motioned to replace "office" with "agency" in the definition "city officer" in the "definitions" section of the charter which was duly seconded. The motion was approved unanimously.

Cleonie Mainvielle motioned to add "on behalf of the city" to the definition of "City Official" in the "definitions" section of the charter which was duly seconded. The motion was approved unanimously.

Thomas Golden motioned to remove the word "the" from the definition of "commission" in the "definitions" section of the charter which was duly seconded. The motion was approved unanimously.

Thomas Golden motioned to extend the meeting by 30 minutes passed 8 pm which was duly seconded. The motion was approved unanimously.

Thomas Golden motioned to change the language in the definition of "Emergency Measure" in the "definitions" section of the charter which was duly seconded. The motion was approved unanimously.

Cleonie Mainvielle motioned to add language to the definition "Emergency" in the "definitions" section of the charter which was duly seconded. With a vote of 3 yea, 2 nays, the motion was approved.

Cleonie Mainvielle motioned to replace "body" with "City Council" in the definition of "Resolution" in the "definitions" section of the charter which was duly seconded. The motion was approved unanimously.

Thomas Golden motioned to change the definition of "Special Election" in the "definitions" section of the charter which was duly seconded. The motion was approved unanimously.

Cleonie Mainvielle motioned to change the definition "Voters" to "Registered Voters" and change the definition of "Registered Voters" in the "definitions" section of the charter which was duly seconded. The motion was approved unanimously.

Cleonie Mainvielle motioned to add a definition for "legislative powers" to the "definitions" section of the charter which was duly seconded. With a vote of 2 yea, 3 nays, the motion was not approved.
