President Gallagher asked if there was anyone speaking in favor – None came forward.

President Gallagher entertained any questions from councilors:

• Councilor Linde asked why the Finance Committee's vote was not unanimous. Mr. Dutton stated he believed it was related to the CPC funding which has since been amended.



- Councilor Colombotos asked if the CPC vote is binding? Mr. Dutton responded, yes, it's binding. Once they made a recommendation, the Council can approve or not approve.
- Councilor Fitzgibbons noted; he has had an order waiting in the Budget & Finance Committee for a while. He thinks it's time for the Town Manager to come up with a building maintenance plan.

7:10 p.m.: FY2021 Budget Hearing

President Gallagher opened the hearing at 7:21 p.m.

President Gallagher referred to the Town Manager for explanation. Mr. Dutton spoke about the challenges in developing a balanced budget during the current times. He noted the state has not provided their numbers yet. There is a proposed transfer of \$1.5 MM from stabilization to assist with funding the budget, which would normally never be done. Roughly half the \$1.5MM is allocated to school and half to the Town. There are no major initiatives funded in this budget and no reserve objectives. The focus is to ensure we do the critical work needed with limited staff. There is no expectation that this is the last time we'll be looking at this budget. President Gallagher invited any questions from the public:

- Dr. Hunt asked if the transfer to the energy fund means it's a revenue stream now? Mr. Dutton explained that is essentially an accounting function. There are solar credit that need to be transferred. Yes, it could be considered a revenue stream.
- At Councilor George's request, Attorney Rawlins clarified the appropriate time to make any amendments is during legislation for action.

President Gallagher asked if there was anyone speaking in favor – None came forward.

President Gallagher asked if there was anyone speaking in opposition – None came forward.

President Gallagher entertained any questions from councilors:

President Gallagher closed the hearing at 7:34 p.m.

## **CITIZENS OPEN FORUM**

- Marilee Hunt, 80 Austin Street: Town Clerk Marilee Hunt spoke about the election, which will run from 10:00 a.m.
   4:00 p.m. and the safety protocols in place. Ms. Hunt noted Raynham has since changed their hours to mirror Bridgewater hours.
- Ed Ivaldi, 10 Boxwood Lane: Mr. Ivaldi spoke about the election and reminded the district 6 citizens of the consequences of the election. Mr. Ivaldi reminded all about the controversy of Mr. Wood's candidacy. He spoke about ethics and character necessary for a Councilor.
- Lauren Webb, Union Street: Ms. Webb urged the Council to have a discussion about the role of the Police Department in society and as it may relate to the budget.



• Steve Rogan, Howard Street: Thanked Mr. Dutton and Councilor Linde for attending the Stand Up for Justice rally last weekend. Mr. Rogan runs the Historical Commission page. He then spoke about a document found between Bridgewater MA and Bridgwater England from 1846/1847 with a statement about anti-slavery. Mr. Rogan has been in touch with Bridgwater, England and they are interested in being a "twin town" with Bridgewater, MA.

### **TOWN MANAGER'S REPORT**

Mr. Dutton reported on information about various activities happening around town and highlighted meetings and events. Items of note included:

Mitchell School Update (Standing Item)

The demolition phase has begun. The building teardown will take place after the July 4<sup>th</sup> weekend. The architect is working towards 90% drawings through August. We are still anticipating a 2022 completion and continue to be on budget. The next meeting is July 29<sup>th</sup> via Zoom. More information can be found at <a href="https://www.bridgewaterschoolproject.com">www.bridgewaterschoolproject.com</a>

Councilor Fitzgibbons asked if we are still on track with state filings, etc.? Mr. Dutton responded, yes. The MSBA has reviewed all submissions and have had very little comment.

CARES Act and FEMA Funding

Mr. Dutton explained the CARES act funding and the allocation of the funds through Plymouth County. We apply to FEMA first, who reimburses 75% of eligible costs and the CARES Act reimburses the 25%. The town has submitted a reimbursement claim to FEMA for \$287,544 (which is 75% of \$336,716). The balance was included in the CARES Act funding which was also submitted last week.

- President Gallagher asked if all the expenses incurred from within the FY20 Operating Budget? Finance
  Director, Tony Sulmonte responded; these are expenses related to items not budgeted for; for example, PPE.
  Mr. Sulmonte provided a detailed explanation of the accounting for the expenses. Mr. Gallagher followed up
  asking if the expenses were paid from the FY20 revenues. Mr. Sulmonte responded, no. Once an emergency
  is declared, the town is allowed to deficit spend for the expenditures not budgeted for.

## **DISCUSSIONS**

Update – Status of Order to Abate Local Meals Tax

Councilor George explained; Attorney Rawlins reached out to the DOR for guidance on what we can and cannot do. He spoke about the real issue being the timing. The earliest it could be effective would have been October, which was well after the intent. Attorney Rawlins confirmed and noted now you have until 8/31 to revoke for October.

President Gallagher read the committee dispositions.

**Motion:** Councilor Fitzgibbons made a motion to approve which was duly seconded.

**<u>Discussion:</u>** Councilor Fitzgibbons noted both the Budget & Finance and Finance Committees both unanimously approved this order and reiterated what the Town Manager said earlier.

<u>Motion:</u> Councilor George made a motion to amend Stabilization to \$1,698,032.00 and Other Financing Sources Total to \$4,558,487.00 and the last sentence total to \$60,194,911.00. Line item 292 (BR School District Expense) amend to \$29,623,685.00 which was duly seconded.

<u>Discussion</u>: Councilor George referenced the supplemental appropriation last year and his comment that last year's newly supplemented funding to the school should be the starting point for FY21, which is what he is doing here. Attorney Rawlins stated you can't increase the budget without a corresponding decrease. Discussion followed regarding the proposed amendment and the purpose and appropriateness based on the Charter. Attorney Rawlins reiterated; for the annual budget, the Council can amend by increasing line items and decreasing corresponding items. The Charter doesn't grant authority to increase the top line of the budget through Stabilization. President Gallagher spoke about the process stating we were always in agreement that Raynham was going to put in the corresponding amount. We were told 2.9% was what everyone agreed to. Then Raynham voted a different number. If we can't do it now, Councilor George should work with the Town Manager's office and perhaps put in a resolution. Attorney Rawlins noted; if you make a supplemental appropriation, it will go through the normal process. Councilor George clarified; his intent is was not to get closer to Raynham's number. Councilor George withdrew his motion and Councilor Fitzgibbons withdrew his second.

<u>Discussion (on main motion):</u> Councilor Fitzgibbons asked Mr. Sulmonte how will you be monitoring the revenue numbers? Mr. Sulmonte responded they are monitoring the revenue numbers weekly, noting a slow-down in motor vehicle excise tax and real estate tax payment.

Mr. Sulmonte responded; there was zero revenue in April vs. \$90,000 last year. We're only down \$4,000 for May. We're seeing solid play for June, but not able to do the events. We will get some CARES funding for the extra staff to ensure social distancing. Discussion briefly followed related to what is currently reimbursable under CARES Act. Mr. George asked if Plymouth County denies the reimbursement, is there another avenue? Mr. Sulmonte responded; he can reach out to other communities who are applying through the state to see if they were reimbursed.

- Councilor Fitzgibbons: Thanked the Town Clerk for all the work on the election noting the early voting numbers. Thanked fellow Councilors on budget. Thanked Mr. Gallagher for another good meeting.

  meet via Zoom. We'll reorganize that evening. Mr. Gallagher reminded all to vote Saturday from 10 a.m. -4 p.m.
